## CONTRACT DEFINITIONS:

The above named person desires to acquire membership in the Montana Athletic Club – Bigfork (MAC). The MAC has agreed to waive the registration fee and reduce the monthly dues for this person in exchange that the person will remain a member in good standing at the MAC for a set period of months.

For valuable consideration, the parties agree as follows:

1. In consideration for the waived registration fee and reduced monthly dues, the member agrees that they will continue to pay the dues set by the MAC, which **may be amended periodically**, for the membership for  consecutive months (NO HOLDS), and shall not terminate the membership or fail to pay dues during the period stated.

2. The MAC shall be able to enforce this agreement and collect all dues for the above set months, except in these situations:

(a) If a member decides to cancel before the above set months expire, the monetary difference between the monthly dues structure from the months attended and the monthly dues structure from the contract will be withdrawn automatically via EFT from the member’s bank account. Initial

(b) If member changes his residence to an area more than twenty (20) miles from the MAC, there will be no additional dues collected.

(c) If member dies, becomes physically disabled or ill (letter from physician required for illness), there will be no additional dues collected. Initial

3. If the member decides to cancel their membership before the above set months expire, they will be liable for a \$25 cancellation fee, in addition to the above requirements. Initial

4. In the case of 12-month membership options, the membership will automatically continue after the expiration of the initial agreed upon term, unless membership is canceled by the member at the 12 month mark. Requests for cancellation must be written out and delivered to the Office 14 days prior to cancel date. All other membership options automatically expire at the end of the specified months.

5. This agreement may be enforced by Montana Athletic Club as provided by Montana Law.
